RULES OF MEMBERSHIP 2023

The new membership rules are as agreed and registered by FCA (Financial Conduct Authority).

Community Membership is open to any person over 16 years of age, who is living on Raasay, **Supporter Membership** is open to any person over 16 years of age, who has an interest in/connection to Raasay and who completes an application for membership in the form required by the Management Committee and

- whose application is accepted by the Management Committee.
- is over 16 years of age
- supports the Society's purpose

Explanation of Membership Categories 2023

FOUNDER MEMBERS: those who are already on the Membership Register prior to 2021 with eligibility to vote on important issues and to stand for election to the Board. They will retain all rights as set out in the original CORRA SHARE OFFER PROPOSAL of February 2013.

FOUNDER JUNIOR MEMBERS: will automatically be upgraded to Community or Supporter Members on turning 16 years of age and they will retain all the rights as set out in the original CORRA SHARE OFFER PROPOSAL of February 2013.

Membership to Founder and Founder Junior Member categories are now closed to new members.

New Member Categories from 2021

ORDINARY MEMBERS: open to anyone living on Raasay, or having an interest/connection to Raasay, with the eligibility to vote on important issues and to stand for election to the Board.

JUNIOR MEMBERS: anyone under 16 years of age. They will not be eligible to vote or stand for election to the Board. Junior members will automatically be upgraded to Ordinary Members when they turn 16 years of age and then they will have the rights to vote and stand for election to the Board.

Membership to Ordinary and Junior Member categories are now closed to new members.

Member Categories from September 2023

COMMUNITY MEMBERS: Open to anyone over 16 years of age, living on Raasay with the eligibility to vote on important issues and to stand for election to the Board.

SUPPORTER MEMBERS: Open to anyone over 16 years of age, who has an interest/connection to Raasay, with the eligibility to vote on important issues and to stand for election to the Board.
